

This year has been filled with exceptional stories and developments, all of which are detailed in our full PDF report found on our website.

2 years ago, we unveiled an inspiring video showcasing our Family Support Program, which highlights the strength and resilience of the families with whom we work. In the past year, we unveiled an inspiring video of two of our CORD (Homeless Veterans) Case Managers, who came through the CORD program and now work in it.

A vision for deeper community involvement has been a beacon for our efforts, guiding us towards more meaningful connections and shared successes. Our ever-popular Dancing With the W2 Stars event raised crucial funds, fueling the impactful work we do every day.

This report spotlights the tremendous impact made possible through fundraising efforts and grants. Although we get a huge amount of funding through government sub contracts, 95% of our agency budget goes directly to support our

clients in our three different programs. We serve the most vulnerable populations of any Non-Profit organization, and our clients come first. In most of our Supported Living clients' residences, we provide 24 hour staffing, which is very expensive. Since only 5% of our huge budget funds Administrative costs, we always have needs, including funding vehicles to transport agency clients, office needs, and Administrative support personnel to do Quality Assurance and manage agency finances. "Making a Difference" is not just a phrase; it is the very essence of our work, driving the positive changes in our programs and the lives of our clients.





VALLEY RESIDENTIAL SERVICES: A VISION FOR 2025

As Valley Residential Services (VRS) looks to 2025, we're invigorated by the opportunity to reinforce the foundations that make our community strong.

CORD PROGRAM REVITALIZATION

Our Corps of Recovery Discovery (CORD) Program has been working on revitalization after a long recovery from the COVID pandemic. We are focusing on reconnecting with the RRU at the VA Hospital, which is still not at capacity, and building new connections with other referral sources that allow us to serve those in recovery. Without the federal COVID funding that bolstered us temporarily, we've had to navigate these waters with prudence and a sharpened focus on sustainability. We are committed to rebuilding this critical program to its full capacity, ensuring a continuum of care that our community relies on.

STABILIZING STAFFING

Staff stability is at the forefront of our agenda. Our Supported Living Program forms the core of our services, and we are dedicated to creating an environment that not only attracts but also retains the compassionate professionals who bring our mission to life. We will continue to educate our State legislators, who appropriate funding for Supported Living, and push for equity in Direct Support wages between Supported Living and State-Operated Living Alternatives. This takes a strong commitment in an industry where the Statewide turnover rates loom at 72%. We are happy to report that the VRS Supported Living turnover rate was MUCH LESS than the State average in all preceding years, but it is still a big challenge with the multiple requirements that we have in staffing our clients.

A FOCUS ON HOUSING

Housing remains a pressing issue, and our collaborations with Blue Mountain Action Council and the Housing Authority of Walla Walla are more crucial than ever. We're developing sustainable solutions for affordable housing. Our commitment to secure housing is unwavering. With these focused efforts, we step into 2025 ready to embrace the challenges and triumphs that await.

EMPLOYEE SPOTLIGHT #1

My first experience with the CORD Program was back in 2011 as a client who desperately needed the structure, support, and services that the program had to offer. With their guidance, I was able to access much-needed mental health and medical treatment through the VA while living in a clean and sober environment. Once I was stabilized I was able to begin working on becoming self sufficient through budgeting, seeking gainful employment, and paying down debt while increasing my savings.

This journey led me to enroll in school at Walla Walla Community College where I graduated with honors with a degree emphasis in chemical and alcohol dependency, all while living in CORD housing. Once I graduated from the program, I decided to continue on with my education and ultimately graduated from Central Washington University with a Bachelor's Degree in Psychology.

I then returned to the Walla Walla area with the intention of giving back to the program that saved my life. I started out as a house manager for the College Place houses and eventually worked my way up to supervisor of case management, which is the position I currently fill today.





Jersey Mike's Subs opened a new location in College Place in early January, launching a fundraiser in support of Valley Residential Services. Through their efforts, they raised \$2,000, and we sincerely appreciate their generosity and commitment to our community.















This initiative holds special significance for us, as 2024 was the year we had to really combat the effects of COVID 19 on clients and staff members. We believe that actively involving adults with developmental disabilities and veterans in recovery in community events and activities is essential for their well-being and overall growth.

During the COVID 19 pandemic, the global health crisis took a toll on everyone's lives, but the impact was particularly pronounced for those already facing challenges. VRS' Supported Living Program had to adhere to Nursing home standards as far as masking and integration in the community. It has been a long and concerted effort the past few years to get our clients connected in the community again.

Recognizing the importance of community engagement, VRS has set its sights on facilitating a renewed sense of belonging for our clients. Participation in community events and activities not only enhances the quality of life for our clients but also contributes to the overall vibrancy of the community. It is a mutually beneficial relationship that foster understanding, breaks down barriers, and creates a more inclusive society.

One of the challenges we face in pursuing this goal is the associated costs. It's not just about the expense of our clients' participation; it also involves the cost of our dedicated VRS employees who provide crucial support. Additionally, transportation is a significant and often overlooked cost. Getting our clients to and from various community events often requires specialized vehicles, trained staff, and careful planning.

VRS secured a Rural Equity Grant in 2023 through Walla Walla County. This grant empowered us to hire an Activities Coordinator, a dedicated professional committed to curating and coordinating a variety of community-based experiences for our clients. We are continuing to fund this position, and that of our Cooking and Craft Class Coordinator, through grants and proceeds with our yearly fundraiser. The Cooking and Crafts classes were also originally funded through Walla Walla County, and we continued this after funding was over.

As we continue to focus on Community Activities and Inclusion, we understand that it requires a concerted effort to fundraise and find sponsors and grants. The difference in our clients is remarkable when they are able to fully engage in community events and activities. Valley Residential Services is committed to making a lasting impact, one that extends far beyond our organization and resonates within the hearts of those we support.

I was hired as an FPS provider, and over time, I've added Family Support admin work to my responsibilities. Most recently, I've taken on FFT, expanding my role even further. I've been with Valley Residential for almost two years now—my anniversary will be in August.

What I love most about working here is the support I get from my colleagues. My direct supervisor, Nancy, is an incredible mentor. She's a wise and experienced human who I can learn from every day. I love that Valley Residential is a "do as I do" environment rather than a "do as I say" one. I reached out to Nancy and Valley Residential when I wanted

a place where I could truly grow and practice FPS services. I told her that I liked to think outside the box, but I'd had some negative experiences at other agencies where my ideas weren't allowed to flourish. Nancy gave me the space to grow both professionally and personally, which speaks volumes about her and the supportive culture here.

The culture at Valley Residential is something special. It's a place where people are happy to be here. There's always a smile, a friendly face, and people greeting each other in the halls. Everyone here adds value to our mission, and I think that's what allows us to carry positive energy to our clients and our community.
